

FACTS	WHAT DOES CLEARWATER CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives you the right to limit some, but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the products and services you have with us. This information can include your: Social Security Number and account balances, Transaction, loss, or credit history, and/or Employment information and assets.
How?	We need to share your personal information to run our everyday business. In the section below, we list the reasons financial institutions can share your personal information, the reasons we choose to share, and whether you can limit this sharing.

When you are no longer a member, we continue to share your information as described in this notice. However, you can limit that sharing at any time using the methods above.

WHAT WE DO			
How does Clearwater Credit Union protect my personal info?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.		
How does Clearwater Credit Union collect my personal information?	We collect your personal information, for example, when you: Open an account or shows your government-issued ID, • Apply for a loan or use your debit or credit card, or • Make account deposits or withdrawals. We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.		
What can't I limit all sharing?	 Sharing for affiliates' everyday business purposes-information about your creditworthiness, Affiliates from using your information to market to you, or Sharing for nonaffiliates to market to you. State laws and individual companies may give you additional rights to limit sharing.		
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.		

DEFINITIONS		
Affiliates	Companies related by common ownership or control. They can be financial or nonfinancial companies.	
	Clearwater Credit Union has no affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial or nonfinancial companies.	
Nonamilales	Nonaffiliates we share with can include insurance and financial services companies.	
laint Markatina	A formal agreement between nonaffiliate financial companies that together market financial products or services to you.	
Joint Marketing	Our joint marketing partners include insurance companies and financial services companies.
